## Monitoring the state of statistical operations under the COVID-19 Pandemic in the Asia-Pacific region

Highlights from a global COVID-19 survey of National Statistical Offices


This report presents a summary of the Asia-Pacific results of the global survey on impacts of the COVID-19 pandemic on the NSOs. The survey lunched on 5 May 2020, it is the first wave of a global survey to assess the impacts of the pandemic on the operation of NSOs, their responses, and the ensuing needs of financial and technical support. The global survey was carried out under the aegis of the United Nations Department of Economic and Social Affairs Statistics Division (UNSD), in partnership with World Bank's Development Data Group and in coordination with the UN Regional Commissions (https://unstats.un.org/unsd/covid19-response/covid19-nso-survey-report.pdf).

40 percent of the headquarter offices of NSOs in Asia-Pacific were fully or partially closed, and more than half of them completely stopped field data collection involving face-to-face interviews. This compares to about 65 percent globally fully or partly closed and 96 percent globally who fully or partially stopped face-to-face data collection.


Nearly 75 percent of NSOs in Asia-Pacific had to postpone fieldwork for planned censuses, and surveys were affected in one-third of NSOs in Asia-Pacific.


The top challenges faced by NSOs in Asia-Pacific are mobility and transportation restrictions, followed by office IT not being suitable for remote work and funding limitations.

The majority of NSOs in Asia-Pacific are willing to adopt new modes of data collection or use alternative data sources.


Despite more than half of the NSOs in Asia-Pacific needing support to face the challenges posed by the COVID-19 crisis, only a quarter of them have received technical or financial supports.







- Nearly 50 percent of NSOs in Asia-Pacific were fully or partially closed.
- 82 percent have instructed some or all of their staff to work from home.
- More than half have completely stopped field data collection involving face-to-face interviews.












- Production of essential monthly and quarterly statistics are moderately affected in more than 50 percent of NSOs in Asia-Pacific.
- Production of administrative data was more resilient to COVID-19 impact yet they were moderately or severely affected in more than 40 percent of NSOs in Asia-Pacific.




Approximately 60 percent of NSOs in Asia-Pacific had to alter their scheduled calendar of publications or data dissemination as a result of the pandemic.











Are you facing difficulties in operating due to:

Has your funding been affected due to the current COVID-19 pandemic?













- 67 percent of NSOs in Asia-Pacific had to postpone or cancel some or all preparatory activities for planned censuses.
- In 73 percent of NSOs, fieldwork for planned censuses had to be postponed to later in 2020 or 2021 and beyond.
- Population and housing census are most affected.


Preparatory activities for planned census?

Field work by type of census









- Surveys were affected in one-third of NSOs in Asia-Pacific.

Due to COVID-19 pandemic, did you have to stop or postpone the field work of this survey?














If you had to alter a planned survey, which changes did/will you introduce?



Has your institution planned any survey on COVID-19 and its impacts?













Is your institution using non-traditional data sources/approaches to analyze or monitor aspects of the COVID-19 pandemic?




- More than half of the NSOs in Asia-Pacific need support to face the challenges posed by the COVID-19 crisis.
